## ELIGIBILITY

To be eligible to our financial assistance, your organization must meet the following criteria:

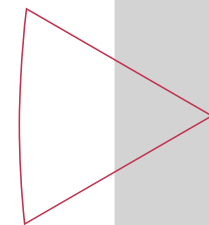
- Having a charitable number issued by the Canada Revenue Agency (CRA) and a First Nations establishment or constituent supported or sponsored by an organization recognized by the CRA
- Able to provide a donation receipt for the total amount of the donation
- Offering services or activities in the Province of Quebec
- Providing proof of continuous and uninterrupted management by producing financial statements in accordance with generally accepted accounting principles
- Having an established Board of Directors and a clear set of internal management and administrative guidelines
- Submit for a specific project
- Projects presented must be up to a maximum of \$5,000
- Present a project that is viable without complete financing as the RBA Foundation is not bound to finance full amounts
- One grant application accepted annually

## INADMISSIBLE APPLICATIONS

- Barring exceptional circumstances, the RBA Foundation will not offer financial assistance to the following: projects benefiting individual or private property, private foundation and/or private clubs
- Project that need global funding

- Reach of the project
- Impacts created as a result
- Added value for our communities
- Innovation of the project
- Sustainability of the organization and its project
- Field of intervention and sector targeted by the project
